

Comparing the wars of decolonization: Extreme violence during reoccupation and counter-insurgency, 1945-1962

During this conference, the theme group *Comparing the Wars of Decolonization* that gathered at the Netherlands Institute of Advanced Studies (NIAS) over the last three months, presents its preliminary results. The theme group project engages in comparative research in order to learn more about causes, forms and nature of (extreme) violence by Dutch military forces in their attempt to re-establish colonial authority during the Indonesian struggle for independence (1945-1949). The theme group and conference are organized by Thijs Brocades Zaalberg (Leiden University / Netherlands Defence Academy) and Bart Luttikhuis (Leiden University / KITLV).

The theme group *Comparing the Wars of Decolonization* is part of the large-scale research program *Independence, decolonization, violence and war in Indonesia, 1945-1950,* carried out by the Royal Netherlands Institute of Southeast Asian and Caribbean Studies (KITLV), the Netherlands Institute of Military History (NIMH) and the NIOD Institute for War, Holocaust and Genocide Studies.
